- **The enclosed entry form with this premium is now a fillable form you can fill out on your computer. This will help us in limiting errors when filling out the forms by hand. We thank you in advance for using this form on the computer to eliminate errors on the data entry side.**
- **No entry fee will be refunded** if the trial cannot open or be completed by reason of riots, civil disturbances, fire, an act of God, public emergency, act of a public enemy, or any other cause beyond the control of the organizing committee. No entry fee will be refunded in the event a dog is absent, disqualified, excused, or barred from competition by the action of the Event Committee.
- **Withdrawals:** For bitches in season pulled after closing, the owner/handler must submit a written or emailed request to receive a refund of entry fees. For dogs pulled after closing due to injury or other medical condition, the owner/handler must submit a written or emailed statement from their vet as to the dog's condition to receive a refund of entry fees. Such withdrawal notifications must be submitted to the Trial Secretary no later than 24 hrs prior to the start of the first class on the first day the dog is entered in the trial to be eligible for a refund of entry fees.
- All dogs should be present at least 30 minutes prior to Judging. The handler is solely responsible for having the dog at ringside. The steward will not search for you.
- Exhibitors will be responsible for picking up after their own dogs. Once identified, those who do not pick up after their dogs will be excused from the trial WITHOUT refund. Please help us keep the show grounds and motel grounds clean. Children must be accompanied by an adult and under control at all times.
- **Liability:** SOTC and its agents, employees, etc. will assume no responsibility for any loss, damage or injury sustained by exhibitors or handlers, or to any of their dogs or property and further assumes no responsibility for injury to children. SOTC reserves the right to decline entries for cause and may remove any dog on account of aggression. No one shall have any recourse or claim against SOTC or any official thereof.

ENTRY INFORMATION

Pre-entry begins 9/20/24 through 10/23/24. Entries must be received by this date. No hand deliveries. Fax, email or unsigned entries cannot be accepted. Express Mail entries must be clearly marked "NO SIGNATURE REQUIRED". All entries must be legible and filled out completely.

Entries are on a first come first serve basis. No day of entries. **Please use the enclosed entry form to submit with payment – one per dog for the weekend.**

**Submitting Entries:**

- Exhibitors may enter more than one dog but may handle only one dog in each level per element of the Trial.
- In the Nosework Trials section of the entry form, enter the appropriate Section, “A” or “B”; you must enter B if you teach nose work OR if you’ve earned a title at the level in which you are entered, in another venue. You may enter “A” if you are new to this level or do not teach.
- United Sarasota Obedience and Training Club reserves the right to return incomplete, incorrectly filled out or unsigned entries.
- Pre-entries must be mailed to the Trial Secretary.
- There will be no Day of Entries at these trials.
- Use a separate entry form for each dog entered in this event.

**Waiting List:** United Sarasota Obedience Training Club is offering a Waiting List to fill openings created by entries that are withdrawn after the trial’s closing. A maximum of 12 entries per trial will be placed on the Waiting List. All entries, including wait-listed entries, must be received by the Trial Secretary prior to the trial’s closing. If a withdrawn entry is replaced by a wait-listed entry, a full refund will be issued for the withdrawn entry. Any wait-listed entry that does not move off the Waiting List into the trial will receive a full refund. Withdrawn entries after closing that are not replaced by a wait-listed entry will not receive a refund.

**ENTRY FEES:** \$25.00 for each element for **Novice and Advanced**; there are a total of 4 trials for the weekend.

## **AWARDS**

Placement ribbons will be offered First through Fourth in each element in the A and B Sections.

A qualifying ribbon will be presented to all qualifiers.

New title rosettes will be awarded for new Element and overall Level titles.

## **CLASS TRANSFERS/ MOVE-UPS**

If a move up is required prior to the trial, they will be accepted until 12 noon 2/5/24.

Move-up forms for Friday must be completed before the end of Trial 1 on Friday. Move-up forms for Saturday T1 must be submitted to T2 the Trial Secretary by the end of T2 on Friday. - Elements are divided into Levels “Novice”-“Elite” and further divided into “A” and “B” sections depending on the experience of the dog and/or handler. Be sure to check the rules regarding the divisions. For these classes, dogs will only be searching the elements chosen.
- Handler Discrimination. In Novice, Advanced, and Excellent, one glove must be provided by the handler. In Master level classes a personal item according to the rules for this level.
- All entries must be submitted on the current “Official UKC® Nosework Trial Entry Form”.
- Use a separate entry form for each dog entered in a club’s event.
- Nosework events are open to all UKC registered breeds and mixed-breed dogs with a valid Performance Listing/  
Limited Privilege number/Permanent Registration/Temporary Listing.
- We want you to keep the points earned at UKC Licensed events. Important things to remember:

- All dogs entering UKC events must be permanently registered, have a valid Temporary Listing Number, or a Performance Listing/Limited Privilege number.
- Dog not UKC registered? Apply for a Temporary Listing Number (TL) online at [www.ukcdogs.com/tl-numbers](http://www.ukcdogs.com/tl-numbers). (TL fees are non-refundable, non-transferable and do not apply to the cost of permanent registration.)
- All entry forms must be completed and signed. Incorrect information submitted on the entry form may invalidate your wins.
