7:30 AM to 5:00 PM each day. These licensed Trials will be conducted according to the Rules of the United Kennel Club. Mixed breeds registered with UKC are welcomed to enter these trials.

There have been several UKC rule changes. Please visit [https://www.ukcdog.com/docs/rulebooks/2021\\_obedience\\_rulebook.pdf](https://www.ukcdog.com/docs/rulebooks/2021_obedience_rulebook.pdf). Move-up forms will be available with the Trial Secretary both days. No move-ups either morning. Please make sure that your move-ups for Sunday are completed by the end of the trial on Saturday. All dogs entered MUST be registered with the UKC. Mixed Breed dogs are eligible to enter, but must be registered with the UKC. Obedience and Rally trials will take place indoors on fully matted rings in air- conditioned building. Indoor crating space is limited. There is no parking available overnight at the site.

Entry fees shall not be refunded in the event that a dog is absent, disqualified, excused by a veterinarian or judge or barred from the competition by actions of the show committee, or if the trial is cancelled because of storms, hurricanes or conditions injurious to exhibitors and spectators. Entries withdrawn prior to the trial will receive refunds less \$5.00 fee per day. Refunds will be issued minus a \$5.00/dog administration fee upon request to the trial secretary for a bitch coming into season after the closing date, provided the secretary is notified prior to the start of the trial.

- Pre Novice- Any exhibitor with any dog that has not earned a Novice (UCD) title or its equivalent in any other organization may compete in this class. The exhibitor does not need to own the dog entered. The exhibitor may show two or more dogs in this class. **Restrictions** – Once a dog has earned a Novice (UCD) title or its equivalent, that dog may no longer compete in the Pre- Novice class.
- Beginner Novice- There are no divisions for the Beginner Novice Class Eligibility. Any exhibitor with any dog that has not earned a Open (CDX) title or its equivalent in any other organizations may be entered in this class. The exhibitor does not need to own the dog entered. An exhibitor may show two or more dogs in this division. **Restrictions** – Once a dog has earned a Open ( UCDX) title or its equivalent, the dog may no longer compete in any Beginner Novice Class.
- Novice A: for handlers and/or dogs that not earned their CD title with UKC or any equivalent organization
- Novice B: for handlers who have earned a title of CD with UKC and for dogs that have earned a CD title with any equivalent organization.
- Novice C: for any handler and any dog that has earned a U-CD title or higher.
- Advanced Novice- Exhibitors do not have to enter any other classes or earn any Obedience titles as a prerequisite. As an additional titling class, dogs entered in this class may also enter any other licensed Obedience class at the same trial. Dogs entered in the Advanced Novice class will not be eligible for High in Trial or All Stars points
- Open A: for dogs that have earned their U-CD. Dogs must not have earned their CDX w/ UKC or any equivalent organization.
- Open B: for dogs that have earned their U-CD and earned a CDX either w/ UKC or any equivalent organization. Obedience trainers, w/UKC or any equivalent organization . Obedience trainers, amateur instructors who instruct at this level, handlers and/or Obedience Judges are to exhibit in this class.
- Advanced Open: Exhibitors do not have to enter or earn titles from any other Obedience class as a pre-requisite. As an additional titling class, dogs entered in this class may also enter any other licensed Obedience class at the same trial.
- Utility A: for dogs that have earned their U-CDX. Dogs must not have earned their UD title with UKC or any other equivalent organization
- Utility B: for dogs that have earned their U-CDX. Dogs that have earned a UD w/UKC or its equivalent must exhibit in this class. Obedience trainers, designated handlers, amateur instructors who instruct at this level, and/or judges are to exhibit in this class.
