Notice to Exhibitors

Entries Close at Noon on Wednesday, September 30, 2026

Fax, Email or unsigned entries cannot be accepted. Entries not on the Official AKC Entry Form are not valid. The entry form must include the Agreement and Rules on the reverse side.

Express Mail entries must be clearly marked- **NO SIGNATURE REQUIRED.** No hand delivery of entries accepted. No emailed or photocopy entry forms accepted. Payments via mail in entry is through Check or Money order, no cash. SOTC is using Secreterrier for online entry.

ENTRIES ARE LIMITED to 6 hours of judging on Friday and 8 hours of judging on Saturday. Entries will be taken on a first come, first served basis.

AKC Chapter 1, Section 5: The Event Committee has the right to decline any entries or may remove any dog from its trial for cause. In each instance, the club shall file good and sufficient reasons for doing so with AKC.

ENTRY FEES WILL NOT BE REFUNDED IN THE EVENT a dog is absent, disqualified, or excused by the judge or veterinarian, or barred from competition by the Trial Committee. If Riots, Civil Disturbances, or Other Acts beyond the control of the club makes it impossible to open or complete the trial, No Refund of Entry Fees will be granted.

There are no refunds for withdrawal of entry after closing date. Should an entry be withdrawn prior to closing date, the fees will be refunded minus cost of the on-line entry fees.

Bitches that come into season after the closing date, may have the entry fee returned less \$10 per day, upon written request from the owner or handler on or before date of trial.

Exhibitor Information and Site Rules

NO unentered dogs are allowed on the club premises during these trials per AKC rules.

We have limited crating space and ask that all exhibitors place your chairs in front of your crates. No lounge chairs or x-pens are allowed.

All exhibitors must use the entrance by the fenced in exercise area to the RIGHT of the building when entering and exiting the building.

Parking: Exhibitors must park in front or side lots. The back entrance to the building and back parking area is not available for exhibitors. Signs will be posted and must be followed on both trial days.

Dog Cleanup: All exhibitors are required to pick up after their dogs.

Training and Equipment Restrictions: There is no training use of any equipment during or after trial hours, beginning when the doors open each day. No equipment may be taken outside for any reason. The agility field is not available during trials.

Walkways and Ring Area Conduct: Walkways will be marked with blue tape. Only exhibitors with dogs preparing to enter the ring may cross these lines. As a courtesy to all exhibitors, no standing, sitting, or gathering near the ring. Dogs and handlers are not permitted near the Steward Table

Trial Governance: SOTC trials are held under AKC rules. The Event Committee will address misconduct that is prejudicial to the sport, the event, or the organization. This includes violations of site rules, safety protocols, or conduct standards.

AGREEMENT

I certify that I am the actual owner of the dog, or that I am the duly authorized agent of the actual owner whose name I have entered above. In consideration of the acceptance of this entry, I (we) agree to abide by the rules and regulations of The American Kennel Club in effect at the time of this event, and any additional rules and regulations appearing in the premium list of this event and entry form and any decision made in accord with them. I (we) agree that the club holding this event has the right to refuse this entry for cause which the club shall deem sufficient. I (we) certify and represent that the dog entered is not a hazard to persons or other dogs. In consideration of the acceptance of this entry and of the holding of this event and of the opportunity to have the dog judged and to win prizes, ribbons, or trophies, I (we) agree to hold the AKC, the event-giving club, their members, directors, governors, officers, agents, superintendents or event secretary and the owner and/or lessor of the premises and any provider of services that are necessary to hold this event and any employees or volunteers of the aforementioned parties, and any AKC approved judge, judging at this event, harmless from any claim for loss or injury which may be alleged to have been caused directly or indirectly to any person or thing by the act of this dog while in or about the event premises or grounds or near any entrance thereto, and I (we) personally assume all responsibility and liability for any such claim; and I (we) further agree to hold the aforementioned parties harmless from any claim for loss, injury or damage to this dog. - (Variety) if you are entering a dog of breed in which there are varieties for show purposes; please designate the particular variety you are entering, i.e., Cocker Spaniel (solid color black, ASCOB, parti-color), Beagles (not exceeding 13 in., over 13 in. but not exceeding 15 in.), Dachshunds (longhaired, smooth, wirehaired), Collies (rough, smooth), Bull Terriers (colored, white), Manchester Terriers (standard, toy), Chihuahuas (smooth coat, long coat), English Toy Spaniels (King Charles and Ruby, Blenheim and Prince Charles), Poodles
- (Event Class) Consult the classification in this premium list. If the event class in which you are entering your dog is divided, then, in addition to designating the class, specify the particular division of the class in which you are entering your dog, i.e. A or B division.
- A dog must be entered in the name of the person who actually owned it at the time entries for an event closed. If a registered dog has been acquired by a new owner it must be entered in the name of its new owner in any event for which entries closed after the date of acquirement, regardless of whether the new owner has received the registration certificate indicating that the dog is recorded in his/her name. - Dogs listed in the **AKC Canine PartnersSM Program** may be eligible to enter all-breed AKC Obedience trials at the club's option. These dogs should be listed as All American Dog and must include their AKC Number on the entry form and check the AKC No. box. Sire and Dam information shall remain blank for mixed breed entrants.
